- Applications will only be considered on the basis of previous master’s level study. Undergraduate level study will not be considered.
- Professional Qualifications e.g. Chartered Accountant, may be considered if the qualification has been gained by the awarding institute’s examination route and not through affiliation with another professional body or professional experience.

MSc FINANCIAL MANAGEMENT

This MSc has been designed to give financial professionals the ability to make a crucial contribution where it matters most in business: at the bottom line.

It provides a wide-ranging understanding of financial techniques and their application but does not require a high-level mathematical understanding of finance theories. You will engage in a specialist study of the key areas of: corporate finance; mergers; investments; derivatives; credit risk; and risk management. The knowledge you gain can be applied in very real practical ways.

Careers in the sector depend upon a strong understanding of the foundations and dynamic nature of finance and the vagaries of investment behaviour. The MSc will prepare the way for a career in a wide variety of positions within the finance profession.

Entry

The standard entry requirement for the MSc Financial Management is an undergraduate degree from a recognized institution. Alternatively, you will be admitted onto the MSc FM when you have passed three core subjects.

Course Content

To complete the MSc, you must successfully undertake nine (9) subjects consisting of five (5) core subjects and four (4) electives.
