

The **BSc (Hons) Occupational Safety, Health and Environment (OSHE)** programme is offered by the University of Greenwich (UK), accredited by IOSH and recognized by ACTT.

This qualification can be earned in two (2) years.

The deadline date for registration for the **February 2023 intake** is **30 January 2023**

## DIRECT ENTRY REQUIREMENTS

To be eligible for entry into this programme you must possess one of the following:-

- ◆ Associate’s Degree in Occupational Safety and Health
- ◆ NEBOSH Diploma in Occupational Safety and Health (Level 6)
- ◆ Associate’s Degree/Advanced Diploma in a science of engineering subject & NEBOSH Level 3 Certificate in Occupational Safety and Health
- ◆ Persons with relevant work experience AND certifications, may be considered for entry by the University.

Persons who **do not meet** the direct entry requirements **but possess an Associate’s Degree in a non-HSE field**, may be required to complete the **Fundamentals to Health Safety and Environment** programme, offered by SBCS GLI Ltd., **in the absence of the NEBOSH certificate**, in order to progress to the BSc (Hons) OSHE.

**NOTE: Qualifications will be reviewed on an individual basis in order to confirm eligibility.**

## AIMS & OBJECTIVES

The programme aims to produce an individual with competence across the core disciplines of environment, safety and health practice.

On successful completion of the programme, a student would:-

- ◆ Acquire an in-depth understanding and competence in environment, safety and health practice.
- ◆ Have a detailed knowledge of the relevant legislative base with respect to environment, safety and health.
- ◆ Be aware of the role and function of other environment, safety and health professionals and the value of the team approach to environment, safety and health practice.
- ◆ Develop a full appreciation of the physiological and toxicological effects of exposure to, or contact with, various physical and chemical agents within the occupational environment and be able to identify the means of controlling the hazards presented.

The BSc (Hons) Occupational Safety, Health and Environment Programme is accredited by the **Institution of Occupational Safety and Health (IOSH)**, Europe's leading body for health and safety professionals, which represents 27,000 members in over 50 countries. **Refunds and Payment Plans Policy**

(A) Requests for refunds on certificate, diploma, degree and professional Programmes must be made within one (1) month of the start of classes. In each instance, no refunds will be granted thereafter.

(B) Refunds on certificate, diploma, degree and professional Programmes are subject to an administrative charge of 25% of the tuition cost/module(s)/course fee OR \$500 per module/course, whichever is greater. Registration fees and course materials purchased are non-refundable.

(C) Students in receipt of exemptions after registering for a course qualify for a refund subject to conditions (A) and (B).

(D) When accessing a payment plan a 15% Penalty Fee will be applicable to instalments not paid on the agreed due date unless prior approval to defer is received from the Finance Department.

(E) It is understood that should you fail to meet your payment obligations, SBCS reserves the right to deny you access to face to face or on-line classes; to restrict your access to on-line resources and to withhold certificates and awards until payment is made in full.
