

Accredited by the University of Sunderland, this one-year top-up programme enables students who have completed the Higher National Diploma (HND) in Mechanical Engineering to advance their qualification to a full honours degree.

The **BEng (Hons) Mechanical Engineering (Top-Up)** programme is designed for aspiring incorporated engineers as it equips students with the practical and analytical skills needed to thrive in today's fast-evolving engineering landscape. Incorporated engineers play a vital role across the industry—from product development and testing to manufacturing and implementation.

Students will gain hands-on experience with industry-standard equipment and learn how to apply engineering principles to solve real-world problems. The curriculum blends theoretical knowledge with practical application, preparing graduates for both immediate employment and long-term career growth.

The aims of the programme are:

- To develop graduates capable of applying mechanical engineering principles to design and implement effective solutions
- To cultivate the skills and professional attributes required for success as incorporated engineers.
- To foster an understanding of engineering's impact within broader economic, environmental, and social contexts.

Step 1 - Confirm your eligibility. Forward soft copies of the following to UOSEng@sbcs.edu.tt

- Original certificate and transcript or official transcript and completion letter from the awarding educational institution
- National ID or Passport
- For students with qualifications more than five years old, a resume listing positions held and key responsibilities will be also required.

Administration must confirm of your eligibility before you apply.

# **Refunds and Payment Plans Policy**

- (A) Requests for refunds on certificate, diploma, degree and professional Programmes must be made within one (1) month of the start of classes. In each instance, no refunds will be granted thereafter.
- (B) Refunds on certificate, diploma, degree and professional Programmes are subject to an administrative charge of 25% of the tuition cost/module(s)/course fee OR \$500 per module/course, whichever is greater. Registration, administrative fees and course materials purchased are non-refundable.
- (C) Students in receipt of exemptions after registering for a course qualify for a refund subject to conditions (A) and (B).
- (D) When accessing a payment plan a 15% Penalty Fee will be applicable to instalments not paid on the agreed due date unless prior approval to defer is received from the Finance Department.
